Still highly sought-after on the second-hand market, the PRIVILEGE 615 remains a benchmark among large cruising catamarans. It stands out for its build quality, refined finishes, exceptional comfort, and outstanding sailing performance. ZUBEN UBI has belonged for 8 years to its second owners, a couple who have sailed the entire Mediterranean aboard her. Never chartered and always used privately, without crew, this long-range catamaran has been exceptionally well maintained and regularly upgraded by its owners. Two major refits were carried out in 2009 and 2019, including a completely redesigned saloon, a fully refurbished galley, renovation of the electrical systems and navigation equipment, as well as numerous technical and comfort improvements. The boat thus benefits from modern equipment while retaining the qualities that make the Privilege 615 renowned. The interior layout is particularly well-suited for long-distance cruising. The central owner's suite forward, located on the bow, offers generous space and excellent privacy. Two guest suites are situated aft, while a fourth cabin on the starboard bow has direct access to the forward bow. For sailing, the boat is exceptionally well-equipped with a spinnaker, gennaker, Parasailor, and a genoa on an electric furler. The two helm stations on the flybridge provide excellent visibility and allow full enjoyment of the Privilege 615's sailing capabilities. Accessible via two side staircases, the flybridge is perfectly proportioned and serves as a true living space, comfortable both under sail and at anchor. For life on board and long-distance cruising, ZUBEN UBI features air conditioning, a wine cellar, an ice maker, a lithium battery bank, and two watermakers, along with numerous systems designed to ensure autonomy, comfort, and safety. A true long-range cruising catamaran, ready to continue its journey in the Mediterranean or set off on new long-distance adventures. With its exclusively private use, complete absence of charter history, major refits, and high level of equipment, ZUBEN UBI represents a rare opportunity in the second-hand catamaran market. A PRIVILEGE 615 perfectly suited for those seeking a high-end, comfortable, seaworthy, and self-sufficient cruising catamaran at a particularly attractive price compared to the cost of a new catamaran today.
